We are searching for a full-time General Dentist at our Wapello County Clinic in downtown Ottumwa. The position will provide direct and appropriate clinical care and treatment to chronic and acute patients in an outpatient clinic setting.

#### MINIMUM QUALIFICATIONS:

**Education:** DDS or DMD from an accredited educational institution.

1. Licensed to practice dentistry in Iowa.

4. Demonstrated expertise in relevant medical practices, protocol, trends, and best practices in clinical areas assigned.

**Working Conditions:** General office and dental office conditions. This position is in an Outpatient Clinic that includes four full time family practice providers, five full time pediatric providers and five behavioral health therapists with four psychiatric providers in addition to the four dentists, dental practice.
